

# THE 'PANDEMIC OF THE UNVACCINATED' HOAX

## How the CDC Conducts Statistical Fraud to Create the Illusion of Unvaccinated COVID Cases

The latest narrative being used to sow division and push the COVID agenda forward as part of the psychological warfare and divide and conquer strategy is a fictional story about the "Pandemic of the Unvaccinated." You can hear Joe Biden push this propaganda in his repulsive tan suit, [here](#).

In order to understand how this narrative is taking shape, we must first understand how the CDC defines a **fully vaccinated person**. [According to the CDC:](#)

*In general, people are considered fully vaccinated: ±*

- *2 weeks after their second dose in a 2-dose series, such as the Pfizer or Moderna vaccines, or*
- *2 weeks after a single-dose vaccine, such as Johnson & Johnson's Janssen vaccine*

*If you don't meet these requirements, regardless of your age, you are **NOT fully vaccinated**. Keep taking all [precautions](#) until you are fully vaccinated.*

Without subscribing to any conspiracy theories whatsoever, and by using the **CDC's own definition**, we now understand that if an individual is injected with any COVID vaccine and then falls ill 1-13 days and 23 hours after injection, that individual will **not be considered a fully vaccinated person by the CDC**.

What this means is, if an individual goes to a hospital 1-13 days and 23 hours after injection and tests positive for "COVID" – that individual will be classified as an **UNVACCINATED COVID CASE**.

So, when we see headlines [such as this one](#) which make the following deceptive and misleading claim, we can rest assured that these people are liars and propagandists, given that the CDC makes no distinction between individuals who have not received any injection, and those who received one, 1-14 days ago.

Of the **8,787 people** who have died in Texas due to COVID-19 since early February, at least 43 were fully vaccinated, the Texas Department of State Health Services said.

**That means 99.5% of people who died due to COVID-19 in Texas from Feb. 8 to July 14 were unvaccinated**, while 0.5% were the result of “**breakthrough infections**,” which DSHS defines as people who **contracted the virus two weeks after being fully vaccinated**.

**No. That’s not what it means**. What it actually means is that of the 8,787 who died in Texas “due to COVID-19”, only 43 of them died **after 14 days** of receiving their second vaccine (or first for J&J/Janssen). The rest either have never received a vaccine, or received an injection 1-13 days and 23 hours prior to their death. So we don’t have enough information to know how many of those 8,787 people were injected prior to their deaths or were **never injected at all**.

What this means (based on the CDC’s definition), is that if 100% of these people (minus the 43) were injected and then died from the injection or another cause between 1-13 days and 23 hours, their deaths would be classified as UNVACCINATED COVID DEATHS, based on nothing but statistical fraud and a meaningless positive PCR test result.

It should further be noted that in some states, [hospitals are not required to report to the CDC hospitalization of vaccinated persons](#).

*"DSHS **doesn't track** the number of COVID-19 hospitalizations among vaccinated people statewide because hospitals are **not required to report that information**"*

But somehow they can say "all new COVID-19 cases and hospitalizations in the area have been among unvaccinated people." Clearly that makes no sense.

In theory, these individuals could have died as a **direct result of the injection** or, as the article admits, something else entirely.

*The agency said nearly 75% of the 43 vaccinated people who died were fighting a serious **underlying condition**, such as diabetes, heart disease, high blood pressure, cancer or chronic lung disease.*

So they will readily admit that the deaths among the 43 vaccinated people may have been due to an underlying condition, but they won’t extend the same logic to the other 8,744. Further, it should be stressed that of these remaining 8,744, many of them may have been injected right before they died, but the CDC is

hiding that information from the public by [undercounting vaccinated COVID cases.](#)

As the CDC openly [admits on their own website:](#)

*However, a small percentage of people who are **fully vaccinated** will still get COVID-19 if they are exposed to the virus that causes it. These are called “**vaccine breakthrough cases.**” This means that while people who have been vaccinated are much less likely to get sick, it will still happen in some cases. It’s also possible that some **fully vaccinated** people might have infections, but not have symptoms (asymptomatic infections).*

Now that we understand what the definition of a **fully vaccinated** person is, we also understand that the CDC is not counting people who get sick, hospitalized and/or die 1-13 days and 23 hours after receiving their injection as a **fully vaccinated person**. Which means they are counting these injected people as **UNVACCINATED INDIVIDUALS.**

**Pay special and careful attention to how the CDC uses manipulation to deceive:**

*There is some evidence that vaccination may make illness less severe in people who get vaccinated but still get sick. Despite this, **some fully vaccinated** people will still be hospitalized and die. However, **fully vaccinated people** are much less likely to be hospitalized or die than people with similar risk factors who are not vaccinated.*

Translation - People who were injected 14+ days ago are less likely to be hospitalized or die than people who were injected 1-13 days, 23 hours ago.

The CDC is pretending that someone who was vaccinated 1-13 days and 23 hours ago is the same as a person who has **never received an injection.**

They classify both groups as unvaccinated, which is inappropriate and misleading. By doing so, they are creating the illusion of a “pandemic of the unvaccinated” - when in reality, many of these so-called unvaccinated people who are falling ill, hospitalized and/or dying - **HAVE JUST BEEN INJECTED, BUT 14 DAYS HAVE NOT PASSED YET.**

**IN OTHER WORDS, IT COULD HAVE EASILY BEEN THE VACCINE THAT CAUSED THEIR ILLNESS OR DEATH AND THE CDC WILL LABEL THEM AS UNVACCINATED COVID CASES/DEATHS.**

If you've just had your second Pfizer or Moderna shot, or your first J&J / Janssen shot yesterday, or 3 days ago, or 10 days ago or 13 days ago – and you are injured, fall ill or die from the vaccine or a comorbidity, and happen to have a meaningless positive PCR test result ...

**THE CDC WILL CLASSIFY YOUR CASE, INJURY, ILLNESS OR DEATH AS AN UNVACCINATED ONE.**

**ADDITIONALLY - It should also be noted that if you've been vaccinated more than 3 months ago, you are no longer considered a fully vaccinated individual.**

9. "Fully Vaccinated Person" means a person who 14 days prior received a second dose of a 2 dose series or 14 days prior received one dose of a single dose vaccine. A person is not fully vaccinated until this time period of 14 days from the last date of the required dose has lapsed. Additionally, after 3 months from the last dose, a person is no longer considered to be a Fully Vaccinated Person.

**So, there you have it. For individuals who were vaccinated 3 months ago and then became sick or died due to the vaccine or a comorbidity, and have a meaningless positive test result, the CDC WILL CONSIDER YOUR DEATH AN UNVACCINATED COVID DEATH.**
