Probable Cause Statement

22UC07280

A female victim came forward in April 2022 to report that she had been repeatedly sexually assaulted by David Hamblin. The sexual assaults began when she was 6 or 7 years old in the mid 1980's. The victim's family resided in the same neighborhood as David, located in Provo, UT. The victim stated she would regularly play with David's children and had been babysat on numerous occasions by David.

The victim asserted that the first sexual assault that she could recall, occurred when she was playing at the Hamblin residence. The victim recounted a time she had been sexually abused when she was in the basement of the Hamblin home. The victim described a sexual assault where she and two other children were forced to stand in front of David Hamblin while he directed them to take turns, "sucking on his penis." David forced each child to take turns giving him oral sex while he critiqued and criticized their abilities and efficacy of what they were commanded to do. The victim described the shame that she felt and her confusion at the time of the sexual assault. The two other child victims who were present when the assault occurred have both been interviewed and have corroborated what this victim has disclosed.

The next sexual assault described by the victim occurred when she was 7 or 8 years old, just prior to her baptism. This sexual assault occurred at the Hamblin residence in Provo UT as well. The victim reported she was forced, headfirst, into a sleeping bag by David. David then proceeded to use his fingers to digitally penetrate her vagina. David proceeded to force his penis into her vagina. The victim remembered the pain and pressure that David inflicted with his penis. The victim exclaimed that David became frustrated, grabbed her by the ankles, and flipped her onto her stomach. David then straddled the child and inserted his finger(s) into her anus. After this, the female victim described that David then forced his penis into her anus. The victim recalled feeling terror and claustrophobia because her head and upper torso were still trapped in the sleeping bag. This sexual assault ended when David, "made some sounds and tensed up." David walked away, leaving the child feeling trapped in the sleeping bag.

The female victim recounted another sexual assault inflicted upon her by David Hamblin. This occurred at the Hamblin home in Spring City, UT, prior to the victim's 13th birthday. The victim entered David Hamblin's bedroom, where he was laying on his bed with his penis exposed and another adult female was present on the bed. David commanded the victim to perform oral sex on the adult female. David continued to give her specific instructions to "lick everything."

David Hamblin is being arrested and booked into jail on the following charges:

3 Counts F1 Sodomy of a Child 1 Count F1 Rape of a Child 2 Counts F1 Aggravated Sex Abuse of a Child by a Person in a Position of Trust

1 Count Lewdness Involving a Child

We are requesting the David Hamblin be held without bail on these egregious crimes against a child. There are ongoing investigations regarding other victims with David as a perpetrator. David Hamblin

was a licensed therapist whose license was revoked by the State of Utah due to allegations that he was sexually abusing his client(s). Through this investigation, it has been reported that David continues to perform "therapy" under the guise of "healing circles" and upon information and belief, the abuse may be ongoing. David Hamblin is a threat to the children and citizens of Utah County.

The Juab County Attorney, Ryan Peters, has been selected as a special assistant attorney general by the Utah Attorney General to prosecute this matter, pursuant to Utah Code § 67-8-9(3). Prior to filing, Mr. Peters has reviewed this probable cause statement.

By submitting this affidavit, I declare under criminal penalty of the State of Utah that the foregoing is true and correct. /S/Hines, Elyse
